# Chairman's Annual Report for Financial Year 2023/2024

I have much pleasure in presenting my mid-term annual report for the Royal Navy Club of 1765 & 1785 (United 1889).

### Overview

The first message this year is a particularly uplifting one. We were recently informed that His Majesty the King will remain our Patron, following a thorough analysis of over one thousand organisations which had enjoyed Royal Patronage during the reign of his late mother, Her Majesty Queen Elizabeth II. A member in his own right since 1977, this is exceptionally good news and it is hoped that both His Majesty and HM the Queen will be able to dine with the Club in the not too distant future.

The second message is that, gratifyingly, in the post-Covid world, the past year brought no surprises and proceeded as planned, with a good dinner programme and further development of the AGM format, building on the initial success of 2022. As expected, and without alarm, the membership continues to gently decline at around 5-10 per year, mainly due to "sickly seasons". But with new blood entering all the time from the serving cohort, the Club's future remains undimmed. FY 23/24 accounts passed independent examination without issue once again, with both General and Surplus Funds remaining "going concerns". The small increases in dinner charges and annual subs have helped us meet ever-testing costs and set the finances on a steady course for the next few years: I thank you most sincerely for your acceptance of these. A slight but justifiable revision of previous dinner guest guidance now allows members' guests without any restriction at 2 of our 3 dinners per year: Founders' Day by necessity remains Club guests only to allow the traditional and most significant support of the Admiralty Board.

The final message for this overview concerns the raising of an issue which the Trustees (as legal guardians of our charitable funds) have been wrestling with. This being the natural reduction in Surplus Fund beneficiaries and the concomitant lack of financial efficiency in managing this component of the Club's affairs. This has led to the inevitable proposal to merge with another similar naval charity, thus safeguarding those who qualify but dispensing charitable funds in a cost-effective manner. The Chairman of Trustees has written separately on this matter, the main direction of which is thoroughly supported by the whole Committee – although ultimately it is a matter for the Fund Trustees alone.

# **Membership and Dinners**

As I mentioned above, membership continues to gently, and naturally, decline over time, but remains substantially over 750. The Committee are actively engaged in the process of recruitment, but I would urge you all to remain on the lookout for potential new members and bring them to the Secretary's attention.

After last June's short notice change of venue to HMS BELFAST, and subsequent reduction in numbers due to train strike action (neither factor impacting on the ultimate success or enjoyment of the dinner), the Club turned to the West Country for an excellent Trafalgar night at BRNC under the dinner presidency of the then CO, Captain Sarah Oakley Royal Navy. The 3rd and final dinner in the Financial Year was at the Army & Navy Club, allowing us to present the Club prize to Lt Cdr Helen Taylor and to entertain the Admiralty Board, at which both the Minister of State for Defence in the Lords and our First Sea Lord spoke.

Having recently and spectacularly dined once again onboard the Royal Yacht BRITANNIA in June 2024, our long held aim to dine onboard an aircraft carrier in Portsmouth is now confirmed (as we go to print), with dinner onboard HMS QUEEN ELIZABETH there this coming Trafalgar Night on 17 October 2024. With the excellent help and support of the CO of HMS QUEEN ELIZABETH, Captain Will King Royal Navy, and his XO Cdr Ed Moss-Ward, both Fellow Officers, let us hope that the ship's programme holds. If not we will revert to the long planned shadow booking of the Royal Maritime Club. The Secretary will no doubt keep the membership informed.

## **Charitable Objects**

The Club's charitable status, broadened in 2006 to be gender neutral, is predicated upon "the relief of distressed widows and widowers, orphan children, siblings and dependants of those who have been Members of the Club but who have ceased to be so by death or resignation".

The Club's charitable objects have continued to be met although as mentioned earlier, with only 2 memorialists now it is unsustainable as a charity to spend the same amount on support costs as grants: and with a relatively fixed income this will not change markedly even with more beneficiaries in the future. Although the Chairman of Trustees, whose responsibility it is, has written separately on the subject, I remain confident that the potential merger of the charity side of our club with another like-minded naval charity will have no effect on the delivery of our main Club outcome – that is the fellowship of sea command qualified Royal Navy officers and a good quality dinner programme. Should a merger of charitable funds come about, rest assured that any legal agreement reached in advance will safeguard our current memorialists and encapsulate any future requirements in line with the original intentions of our Founders.

# **Surplus and General Funds**

In short, the annual accounts of both funds were audited at the end of the financial year 2023/24 in April: both funds were declared 'clean'. Each was in surplus, with the General Fund at £2,566 having paid all bills, transferred a sum to the Surplus Fund and subsidised dinners to the tune of £6,614. The Surplus Fund was in surplus at £10,231, with £1,364,453 invested generating £41,405 income over the year.

A very satisfactory annual outcome for both funds

At the end of another good year for the Club, I would like to give my warmest thanks to the Committee members, Trustees and, most notably, to the Secretary, who have all ensured our Club remains relevant and our activities well balanced, keeping open minds and adopting well targeted change where necessary. Fellow Officers can rest assured that the Club's governance is sound and in good hands, acknowledging and supporting in addition the challenge being met by the Trustees in delivering cost-effective charity across the naval spectrum. There will be opportunity to express views at this year's AGM on 5 September in HMS COLLINGWOOD to which you are all encouraged to attend – particularly those members of the RNSWOA who will be able to dine there afterwards!

This is your (our) Club and deserves the very best in the spirit of its Founders. I much look forward to seeing you at future dinners and events.

As is now a well-established Club custom, this dinner will warmly welcome spouses or partners as members' guests should they so wish. A superb location, it is hoped to repeat past June dinner successes.

THE BATTLE OF TRAFALGAR 2025 will be commemorated on Thursday, 30th October 2025in Portsmouth, in the Wardroom HMS NELSON unless a suitable ship is alongside and can take us. The Dinner President and the Principal Guest will be announced later.

### BOOKING AND PAYING FOR DINNER PROCEDURE

In applying for seats at dinner, Members are asked to do so by email or letter, giving the date or venue of the dinner. "Tickets" are not issued to members. For Guest Nights, the title, name and post-nominals of any guests (the usual limit is two per member) should be provided. If you wish the Secretary to send them an invitation card, then please provide him with their address with the appropriate payment. Any seating preferences should be clearly stated, identifying by name if possible those with whom the Member wishes to sit (or not!).

If payment by direct online transfer is desired - the method preferred by the Club - the charge should be sent to Holt's Bank at sort code and account number listed on the printed dinner card mailed to each member. Since this copy of the report is posted on the website, for security reasons those details have been removed from here. It is important to please state surname, initials and month of dinner as the reference. Members are asked to inform the Secretary by email in advance of the intention to pay by this method. Cheques should be made payable to: The Royal Navy Club.

Regrettably, to be fair to all, seats cannot be guaranteed unless payment is received by the notice required, which is given on the Dinner Card (normally fourteen days). Payment on the night is not desirable and is at risk of being lost during a memorable evening! Members desiring a receipt for their dinner charge payment are requested to send an SAE with their payment.

# GUIDANCE FOR INVITING GUESTS (as listed on the Website).

The primary principle is to maintain the ethos of the Club and avoid endangering or disturbing the welfare, good feeling, honour or conviviality of Club occasions. No one eligible for membership may normally be a guest except as provided for in Rule I.

The Founders' Day dinner will continue to be for members only.
